NOTICE IS HEREBY GIVEN that at 10:00 a.m., or as soon thereafter as the matter can be heard, on Thursday, October 26, 2023, a public hearing (the "Public Hearing") will be held by the Board of Directors of the Tehachapi Valley Healthcare District (the "District") with respect to the proposed reissuance (for federal income tax purposes) of certain outstanding bonds defined below as the Bonds by the District in an aggregate principal amount of \$52,070,000, the interest on which is intended to be federally tax-exempt and exempt from State of California personal income taxes. The Bonds as so reissued are intended to qualify as "qualified 501(c)(3) bonds." The Public Hearing is intended by the District to comply with the public approval requirement of Section 147(f) of the Internal Revenue Code of 1986, as amended (the "Code"), and the Treasury Regulations thereunder.

In 2013, the District issued its \$50,000,000 General Obligation Bonds, Election of 2009, Series 2013 (the "2013 Bonds"), to finance a portion of the cost of a new hospital located at 1100 Magellan Drive, Tehachapi, California 93561, which opened in 2018 (the "Project"), and to pay for costs of issuance of the 2013 Bonds. In 2016, the District entered into a Master Facilities Lease ("Master Facilities Lease"), by and between the District and Adventist Health Medical Center Tehachapi ("Adventist"), a nonprofit corporation qualified under Section 501(c)(3) of the Code, and an Affiliation Agreement, by and among the District, Adventist and Adventist Health System/West, a California nonprofit religious corporation d/b/a Adventist Health, concerning the lease and use by Adventist of certain of the District's hospital facilities (together, the "Adventist Lease"). Amounts received from Adventist were used to build a portion of the Project. In 2021, the District issued its taxable \$53,985,000 General Obligation Refunding Bonds, Election of 2009, Series 2021 (Convertible) (the "Bonds"), \$52,070,000 aggregate principal amount of which remains outstanding, to advance refund the 2013 Bonds on a taxable basis, subject to conversion, and to pay the costs of issuance of the Bonds.

The Project is owned by the District and operated by Adventist, and is used for healthcare purposes. The Bonds are general obligation bonds of the District, and Kern County is empowered and is obligated to annually levy *ad valorem* taxes, without limitation as to rate or amount, for the payment of interest on and principal of the Bonds, upon all property subject to taxation within the District (except certain personal property which is taxable at limited rates).

The Public Hearing will be held in the District's Administrative Office Building, which is located at 116 West E Street, Tehachapi, California, 93561. RESOLUTION NO.

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE TEHACHAPI VALLEY HEALTHCARE DISTRICT APPROVING THE DEEMED "REISSUANCE" FOR CERTAIN FEDERAL INCOME TAX PURPOSES OF CERTAIN TAX-EXEMPT BONDS THAT WERE ORIGINALLY ISSUED TO FINANCE AND REFINANCE CAPITAL IMPROVEMENTS WITH RESPECT TO CERTAIN HEALTH CARE FACILITIES

WHEREAS, the Tehachapi Valley Healthcare District (the "District") previously issued its "Tehachapi Valley Healthcare District (Kern County, California) General Obligation Bonds, Election of 2009, Series 2013" (the "Prior Bonds"), in the original principal amount of \$50,000,000, to finance a portion of a new hospital to be located at 1100 Magellan Drive, Tehachapi, California 93561 (the "Project"); and

WHEREAS, in 2016, following a public hearing held by the Board of Directors of the District, the District entered into a Master Facilities Lease, by and between the District and Adventist Health Medical Center Tehachapi ("Adventist"), a nonprofit corporation qualified under Section 501(c)(3) of the Internal Revenue Code of 1986 (the "Code"), and an Affiliation Agreement, by and among the District, Adventist and Adventist Health System/West, a California nonprofit religious corporation d/b/a Adventist Health concerning the lease and use by Adventist of certain of the District's hospital facilities, including the Project (together, the "Adventist Lease"); and

WHEREAS, the Project is owned by the District and operated by Adventist, and is used for healthcare purposes; and

WHEREAS, on December 7, 2021, the District issued its General Obligation Refunding Bonds, 2009 Election, 2021 Series A (the "Bonds"), in the aggregate principal amount of \$53,985,000, pursuant to Resolution No. 21-04 of the Board of Directors of the District (the "Resolution"), adopted on November 9, 2021, for the purpose of advance refunding on a taxable basis, subject to conversion, the District's outstanding Prior Bonds, to refinance the Project; and

WHEREAS, the Bonds were privately placed and acquired by Capital One Public Funding, LLC (the "Lender"); and

WHEREAS, the District and the Lender have agreed to convert the interest rate on the Bonds to the tax-exempt rate specified in the Resolution, on November 1, 2023 (the "Conversion Date"), which conversion will constitute a reissuance for federal income tax purposes of the Bonds, the interest on which is intended to be federally tax-exempt and exempt from State of California personal income taxes; and

WHEREAS, the Bonds as so reissued (the "Reissued Bonds"), in the aggregate principal amount of \$52,070,000, are intended to qualify as "qualified 501(c)(3) bonds" under the Code, and the Project will be deemed to be refinanced by the Reissued Bonds; and

WHEREAS, the Reissued Bonds are general obligation bonds of the District, and Kern County is empowered and is obligated to annually levy *ad valorem* taxes, without limitation as to rate or amount, for the payment of interest on and principal of the Reissued Bonds, upon all property subject to taxation within the District (except certain personal property which is taxable at limited rates); and

WHEREAS, pursuant to Section 147(f) of the Code, and the Treasury Regulations promulgated thereunder, the reissuance of the Reissued Bonds by the District must be approved by the District because the Reissued Bonds are deemed to be reissued by the District, which is a local governmental unit within the meaning of Section 1.103-1 of the Treasury Regulations ("issuer approval"), and because the Project is located within the geographic jurisdiction of the District ("host approval"); and

WHEREAS, the Board of Directors of the District (the "Board") is the elected legislative body of the District and is therefore an "applicable elected representative" of the District, which is required to approve the reissuance of the Reissued Bonds under Section 147(f) of the Code and the Treasury Regulations promulgated thereunder;

WHEREAS, pursuant to Section 147(f) of the Code, and the Treasury Regulations promulgated thereunder, the Board of Directors has, following notice duly given, caused to be held a public hearing regarding the reissuance of the Reissued Bonds, has received a summary of any views expressed by interested persons at the public hearing and now desires to approve the reissuance of the Reissued Bonds by the District;

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Tehachapi Valley Healthcare District, County of Kern, State of California (the "Board"), as follows:

Section 1. The Board, as an applicable elected representative of the District, hereby approves the reissuance of the Reissued Bonds by the District for the purpose of refinancing the Project. It is the purpose and intent of the Board that this Resolution constitute both issuer approval and host approval of the reissuance of the Reissued Bonds by the District as the District is the governmental unit reissuing the Reissued Bonds and having jurisdiction over the area in which the Project is located, in accordance with Section 147(f) of the Code and the Treasury Regulations promulgated thereunder.

Section 2. The President of the Board of Directors, the Treasurer, and the Chief Executive Officer, or their designees, are each hereby authorized and directed to do any and all things and to execute and deliver any and all documents that they deem necessary or advisable in order to carry out, give effect to and comply with the terms and intent of this Resolution and the refinancing transaction approved hereby.

Section 3. This Resolution shall take effect from and after the date of its passage and adoption.

- General Obligation Bonds (\$55.84) should be utilized on bond expenditures and can be moved to Valley Strong.
- Refunding Escrow Bonds (\$1.963221.14) Escrow account, which pays bonds up to 11/01/23 and will be fully paid out by 2023 and go away with the original bond holders.

- GO Refunding Bonds Convertible (\$38,723.97) This is cost of issuance set aside for conversion. Funds to be utilized for any legal expenses. If not converted, these funds should be returned to debt service account as a savings to taxpayers.
- Peggy presented on general accounts:
 - Bank of Sierra accounts all closed and funds transferred to Valley Strong.
 - LAIF (\$4.3M) To remain open with IGT funds transferred to this account.
 - Wells Fargo Account (\$2.7M) Currently used for monthly Computershare Agency Fee. Peggy to transfer funds to Valley Strong and to track funds in house for future project.

- A. Conversion of Bond Tax Treatment (presented first on agenda)
 - Maryann Goodkind, Bond Counsel, presented on the refinancing the 2013 Bond (\$50M). Next steps are to approach bond holder and provide a public notice to allow comment. Capital One has option to convert to tax exempt. Current rate is 3.25%. If Capitol One agrees, rate would drop to 2.5 percent. We will provide notice to request conversion by October 1, 2023; Capitol One has have fifteen days to accept or deny.
